UCONN SCHOOL OF MEDICINE

At the University of Connecticut School of Medicine, the Clinical Skills Assessment Program assists students as they learn bedside manners, the skills of taking a medical history, completing a physical examination, counseling, and communicating with patients. It relies on individuals trained to portray a medical problem and then evaluate students as they encounter the situation. The people who do this work are called Patient Instructors (PIs).

We look for individuals who have the interest and skills to work effectively with medical/dental students in this role. The specific skills we look for are good communication skills, the ability to learn a script and act it out as the patient, comfort answering sensitive questions, ease and ability to provide constructive feedback, and the willingness to have a variety of physical exam maneuvers performed on you by students.

Patient Instructors work part-time and do not have steady hours. PIs work from one half day to five half days a week. Some weeks it could be one full day and one half day. During a half-day they see 4-8 students, portray the case for each one, score each student's performance, and typically give the students feedback. PIs are carefully trained before they begin working with students because they must be accurate in portraying the case and scoring the students. PIs are also trained to give feedback to students on the content and process of the students' work.

We employ people of all ages who can make a commitment to working with students in specific programs. Individuals with medical problems and those with none are equally welcome. At times, the Patient Instructor's own experience is used for parts of a case, but most are authored by faculty and then matched to the age and sex of the potential PI.
